- 1. Louisiana Redfish-Speckled Trout Tournament: Rules stand as written.
- 2. Belize Bonefish Tournament: Rule change- 6. TACKLE/LINE: Spin line is limited to ANDE 12# CLEAR Premium monofilament. Spin anglers may use Rio Saltwater Nylon 12 lb. Tippet attached to their leader is they wish. Fly tackle is limited to Rio Bonefish Tapered 12 lb. Leader and Rio Saltwater Nylon 12 lb. Tippet. All Rio products are available from www.rioproducts.com as well as other tackle shops. Plug, spinning, general tackle and fly gear will be allowed on all boats. Tackle will be used in compliance with all IGFA rules. Each angler should bring her own terminal tackle. Anglers fly-fishing must provide tippet in the correct line size and color. No other line will be permitted.
- 3. Previously a one pound minimum for weight awards but it never was put in the rules in the yearbook.

## MERRILY SIMMONS, TOURNAMENT CHAIR:

The Tournament Wells Fargo account balance is \$57,415.95 with the Venice Louisiana tournament deposit by Hazel of \$33,003.00. 24 anglers paid an entry fee of \$1,425.00 for a total income for the Tournament of \$34,200.00.

There were some outstanding expenses and deposits recently found for the 2014 LTT. The deposits have been placed into the account but I am waiting on invoices for payment of the expenses. Those will not be paid until invoices are received. With those additional expenses, if or when paid, will be over budget by \$1,739.25. I am asking for Board guidance on this issue.

The 2015 Venice Louisiana Tournament budget will be in the red because of processing fees incurred through Memberclicks. The club absorbed those fees last year and apparently I had not made the Committee aware of that. They have not had to buy a disc this year. Their budget is not outrageous and they had not wanted to raise entry fees. If they are close to their budget, they will be over approximately \$977.00 and the Tournament Account funds held in reserve would be used to cover that.

The Bonefish Tournament budget is within budget! Thank you Joan Vandergriff and Gwen Hahn.

The Rules for the Louisiana and Bonefish tournaments have been submitted and Janice Sands has looked them over as she indicated in her report. The Board will vote on those at the May 20th meeting. I am waiting on Cheryl C. about the line change for the LTT. Nothing has been submitted to me or Janice, that I am aware of. I will place a call to her and perhaps by the meeting date I can give the Board some information. I know that Lisa E. is also trying to reach Cheryl.

A blast will be sent out around or on July 23rd that the registration for the 2015 LTT is open; on September 1st the balance due notification will be sent for the 30 days due date of September 19th so those who have registered will have sufficient notice.

# **SNAKEHEAD RULE**

# **CREDIT CARD FEES**

The Louisiana budget is very tight. Tournament chairs wanted clarification there was no Disc expense for this year. Also there had been a \$1,000 reserve from previous year that the tournament chair wanted access to if they went over budget

Merrily reported there remains \$1700 in unaccounted for expenses for LTT where no receipts or invoices have been provided. In the expense allocation was \$600 in award money, which Cheryl paid directly to the guides.

Joan Vandergriff voiced concern about the lack of process for the tournaments, budgets and criteria for tournament chair selection. Also there is concern for the amount of time it takes to submit invoices and receipts for reimbursement.

CONCLUSIONS

The guide fees for LTT will be reimbursed to Cheryl and she will be asked to submit receipts / invoices for the outstanding \$1,100 balance.

Joan also recommended having a note pop up in the upcoming events on the website that might show persons celebrating birthdays that month.

Joan Vandergriff asked if we want to archive minutes from past meetings. At this point we will not archive only display current minutes.

Look into IWFA shirts that members could buy and wear. Also these shirts would be good to use when working booths at tradeshows promoting IWFA. Kathy reported in the past we had used a third party vendor that developed an IWFA storefront where members could order shirts and other items directly. The company had the logo and would print, bill and fulfill the individual item direct to the member. The company would then pay the IWFA a commission for the items sold. It was a little more expensive to the member, but it prevented the issues associated with inventory, order processing and shipping.
